CE Classes: We will have 2 options with each one being 1 CE credit each.

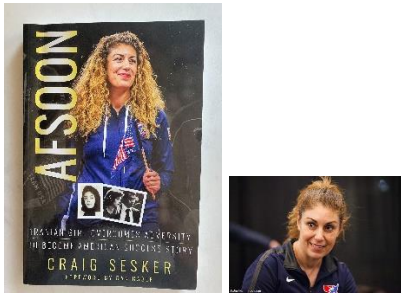
